KICK START TO OUR 24th TRIENNIAL CONFERENCE 26th & 27th FEBRUARY, 2022 ELECTION OF OFFICE BEARERS

The Executive Committee of our Organisation met through virtual mode on 7th December, 2021 and deliberated various issues including details of posts of office-bearers for the ensuing term 2022 - 2025. It was resolved at the meeting to effect restructuring to enhance vibrancy. In compliance of the resolution of the Executive Committee, the matters relating to restructuring are given as per the following details.

In view of the challenges being faced by Banking Industry, the ensuing period is poised to be challenging for bank employees. To keep up the character of public sector banks, our parent organization AIBOC has put in place various plan of action and has resolved to oppose tooth and nail such misplaced initiatives.

Consequent to the closure of Zonal Office, it had been decided to withdraw the post of JGS & DGS (zone) and bring in its place, post of State Secretary, in charge of a State or part thereof or combination of States to ensure effective co-ordination of the affairs of the organisation.

The existing post of two Senior Deputy General Secretaries (All India) and two Deputy General Secretaries (All India) to be combined and named as Deputy General Secretary (All India) to ensure cohesive functioning of Central Unit.

The proposals for rationalization of posts to amend the bye law shall take effect from the ensuing Conference itself.

- c) **Telangana & Andhra Pradesh** : All General Council Members from the states of Telangana & Andhra Pradesh State (Hyderabad, Vijayawada, Visakhapatnam & Warangal Regions are comprised therein)

- d) **Bihar, Jharkhand & Odisha** : All General Council members from the States Of Jharkhand, Bihar, & Odisha (Berhampur, Bhubaneswar, Patna and Ranchi Regions are comprised therein).
- e) **Delhi, NCR Delhi, Haryana, Himachal Pradesh, Uttar Pradesh, (including Mathura, Noida & Ghaziabad District of U.P) UT of Chandigarh** : All General Council members from State of Delhi & NCR Delhi, Chandigarh and Ludhiana Region
- f) **Madhya Pradesh & Chhattisgarh** : All General Council Members from the states of Madhya Pradesh & Chhattisgarh, (Bhopal & Raipur Regions).

The Election will be held at the General Council Meeting at Chennai as per schedule announced by Election Committee.

ELECTION COMMITTEE

To set the election process in motion, an Election Committee has been constituted consisting of the following members:

1. Shri. Nagaraj M - Chief Manager, Secretariat Branch, Chennai
2. Shri. Sridharan B - Chief Manager, Anna Nagar Branch, Chennai
3. Shri. Rajasekar N - Chief Manager, MSME Department, CO
4. Shri. Jeetendra Kumar Panda, Senior Manager (Faculty) Staff College, Chennai.

The Election Committee will be issuing circulars shortly regarding election procedure and filing of nominations for the election of Office-bearers during the General Council.

As per Bye-law 14(g) (i) after the last date of withdrawals contesting for more than one post by a member will invalidate all his nominations.

As per Bye-law 14(g) (ii) no member shall propose or second candidates in excess of the number identified for any specific post. Any violation shall render such nominations invalid.

As per Bye-law 14 (i) (ii) where the number of posts of a position is more than one i.e. Senior Vice President, Deputy General Secretary, Joint Treasurer and Vice President, the delegates should cast their vote for all the posts in that position else the vote shall be treated as invalid.

WE ALSO WISH TO ADVISE THAT DISPLAY OF POSTERS, BANNERS, ETC. BY WAY OF PASTING OR HANGING OR BY ANY MEANS FOR ELECTIONEERING IS STRICTLY PROHIBITED IN THE ENTIRE CONFERENCE COMPLEX INCLUDING THE COMPOUND WALLS AND ALSO IN CENTRAL OFFICE COMPLEX. IF ANY SUCH DISPLAY IS FOUND THE SAME HAS TO BE REMOVED AND REFUSAL TO REMOVE WILL DISQUALIFY THE CANDIDATE FROM CONTESTING THE ELECTION AND HIS NAME WILL BE REMOVED FROM THE BALLOT.

The delegate, proposer, seconder and the contestant contesting the election for office-bearers should have paid subscription/levy in full as on date of circular calling for nomination issued by the Election Committee, else their candidature will be invalid. It is advised that discontinuation from check - off of Subscription under CHRIS-3 would invalidate the Membership of the Organisation and would attract disqualification for being a cluster delegate or for any candidature.
