The Election Committee has laid down the following norms and procedures for the conduct of the Elections.

VOTING SYSTEM	FORWARDING OF NOMINATIONS	
	1. Voting will be by secret ballot system	
	<ol><li>Proxy and post ballots will not be permitted.</li></ol>	
	3. All nominations should be sent to Shri. S.V. PRASSANNA Vice-chairman Election Committee IOBOA C/o. INDIAN OVERSEAS BANK, Corporate Credit Department, Central Office, 762/763, Anna Salai, Chennai 600 002	
HOW NOMINATIONS HAVE TO BE SENT	4. All sealed covers containing the nomination FORMS SHOULD BE SUPERSCRIBED With the words "NOMINATION FORM (IOBOA)" and should either be directly Delivered (or) sent by Registered Post/Courier.	
ELECTION COMMITTEE POWERS	5. If due to unforeseen circumstances and exigencies of service, the elected Chairman of the Committee could not be present to conduct the election proceedings, Vice Chairman and other members will have the powers to conduct the election.	

We enclose printed nomination forms for the use of the members. If necessary, typed forms in the same format or xerox copies of the form may also be used. Incomplete/incorrect forms will be rejected. Separate nomination forms should be used if a member opts to file nomination for more than one post.

For the post of Vice President, Joint General Secretary, Deputy General Secretary, Assistant General Secretary (Reserved for Lady Officers) (Each Geographical Area) the members may file their nomination including the name of the geographical area given in IOBOA Circular No. 5/2025 dated 30<sup>th</sup> June 2025. For Eg. if a member wants to contest for Vice President -South, he/she has to indicate the post as Vice President-South.

We invite reference to Association Bye-law 14(g) (1), 14(g) (ii) and 14(i) (ii) reproduced hereunder.

14(g) (1) A last date shall be fixed for the purpose of withdrawal of nominations. After the last date for withdrawals, contesting for more than one post by a member will invalidate all his nominations.

14(g) (ii) no member shall propose nor second candidate in excess of the number identified for any specific post. Any violation shall render such nominations invalid.

14(1) (ii) Where the number of posts of a position is more than one, the delegates should cast their vote for all the posts in that position else the vote shall be treated invalid.

We also wish to advise that display of posters, banners etc, by way of pasting or hanging or by any means for electioneering is strictly prohibited in the entire conference complex including the compound walls and also in Central Office Complex. If any such display is found the same has to be removed and refusal to remove will disqualify the candidate from contesting the election. Mobile Phone are strictly prohibited inside the election area to ensure voting confidentiality.

We seek the whole hearted co-operation of all the members for the smooth conduct of the election.
