Information We Collect

When you register for access, we may ask for information such as your PF number, date of birth, email address, etc. This is to verify your membership status against our internal database. Only verified members are permitted to access the IOBOA website and mobile app.

How We Use Your Information

We use the information we collect in various ways, including to:

- Communicate with you, either directly or through our partners
- Provide updates and event-related information
- Send you emails
- Prevent fraud and unauthorized access

Log Files

IOBOA follows a standard procedure of using log files. These files log visitors when they access the website. All hosting companies do this as part of hosting service analytics. The information collected by log files includes IP addresses, browser type, Internet Service Provider (ISP), date/time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any personally identifiable information.

Cookies and Web Beacons

Like many other websites, IOBOA uses cookies. These cookies are used to store information such as visitor preferences and the pages visited. This information helps us optimize the user experience by customizing web content based on browser type or other information.
